
THIS DEED of Foundation and the day of AUGUST 1998 by SRI.G.ASHOKAN, Son of SRI.A.M.S.GANESAN, aged about 40 years residing at 83/B-2, Gnanagiri Road, Sivakasi hereinafter called the "AUTHOR" of the Foundation which term wherever the context so requires shall mean and include his legal heirs, legal representatives, executors, administrators and assigns witnesseth:

WHEREAS the Author of the Foundation has been having an intention to create a PUBLIC CHARITABLE FOUNDATION with a view to provide the poor and needy Educational aids so required as well as for sports without any distinction as to caste, creed or religion or sex.

WHEREAS in pursuance of such a desire, he has constituted this Foundation under these presents.









NOW THIS DEED OF PUBLIC FOUNDATION WITNESSETH:

The Author does hereby constitute a Public Charitable Foundation which shall function as non-profit making organisation providing benefits to the General Public without any discrimination of caste, creed or religion or sex and endows a sum of Rs.5006/-(Rupees five thousands six only) as a corpus nucleus fund and declares that he and the other trustees appointed hereafter will hold the said fund and all other funds and properties received and acquired and all the income arising from properties held under the Foundation by the trustees for the various public charitable objects specified hereunder in Foundation for application on all or any of the objects specified hereunder.

NAME:

The name of the Foundation shall be " ARASAN A.M.S.G. VIJAYAKUMAR MEMORIAL FOUNDATION ".

MANAGING TRUSTEE:

The Author Sri.G.ASHOKAN will be the first Managing Trustee, who shall hold the office for life or until he resigns. In case of his resignation, he shall have the right of nominating his successor to act as the Managing Trustee in his place till his life time. After his life time the senior most male adult descendant of the members of his family according to the rule of lineal primogeniture shall hold the office in succession for life and in case of any successor being disqualified or resigning the next succession according to the said rule shall be entitled to take his place for life. In case of such senior male child being a minor, the Board can elect one of the Trustees as Managing Trustee. The tenure of such Managing Trustee is for three years or until the child becomes major whichever is earlier. Such Managing Trustee is eligible for reappointment also.

TERM OF OFFICE:

- 1. The Trustees shall hold office for Life.
- The Board may remove any trustee other than Life Trustee by passing a resolution which is approved by at least two thirds of the total number of the Trustees of the Foundation for the time being.
- If any Trustee wants to resign before his tenure, he may do so with the consent of the Board.

POWERS AND DUTIES OF THE MANAGING TRUSTEE & BOARD:

The Board shall have the following powers and it may, by resolution delegate such powers to others as may be specified in the said resolution.

a) The Board shall manage the Trust properly and after paying Government Revenue, taxes and all expenses of collection and management, he shall use the balance of the income as well as the income from such funds as may be got later and any addition thereto as may remain in their custody and income from any other securities which they might get, which may hereafter be converted by them into any other form as permitted. All these may be used for the expenses of the said charitable purposes and any balance remaining after making such expenses shall be deposited in such manner as the Trustee may consider proper and reasonable.

o) The Board shall forthwith apply the foundation funds in any of the forms of investment allowed to him/her by the existing law and may from time vary such investments for others of a like nature as often as he/she shall deem expedient and necessary consistent with the legal requirements of the times in which the Foundation functions and the objects of the Foundation and the chairman shall have power to hold business undertakings as property held under Foundation and apply the income of such property for the objects of the Foundation.

- c) All money received by the Board and not required for immediate expenditure within three months for the purpose of Foundation may at the discretion of the Board be applied in any of the forms of the investments he/she deems expediegt and necessary consistent with the legal requirements of under section 11(5) read with section 13(1) (d) of the Income-tax Act 1961.
- d) All the properties, funds and assets of the Foundation shall vest in the Board and the Managing Trustee shall be completely in charge of the management of the affairs of the Foundation.
- e) The Managing Trustee shall have all the powers for administration of the Foundation affairs including the power to employ, remove employees etc. Such employees shall look after the day to day administration of the Foundation under the supervision and control of the Managing Trustee of the Foundation.
- f) The Board may meet for the despatch of business, adjourn and otherwise regulate their meetings, as they think fit.
- g) The Trustees shall have power to augment the funds of the Foundation from any source by accepting donations and voluntary contributions or requests of any kind subject to any conditions the Board or the Donor may prescribe.

- h) Without prejudice to the above such general powers, the Managing Trustee shall have the following powers:
 - To purchase lease licence, letout, provide, erect, maintain and keep up lands, buildings, equipment and materials and to sell, mortgage or dispose of all or any of the same as the Trustees may think fit.
 - To execute, become party to, sign, acknowledge, perfect and register all deeds, agreements, etc. and to give effective discharge on behalf of the Foundation.
 - 3. To open and close accounts with Banks in the name of Foundation, to operate upon any such accounts, and for this purpose to sign necessary forms, to pay and draw money from such accounts and otherwise deal with same.
 - To insure and keep insured, if deemed expedient, all or any of the buildings and other assets of the Foundation.
 - 5. To make applications to authorities for permission to carry on the object of the Foundation specifically drawing the attention of the authorities to the fact that the Foundation is a non-profit making organisation.
 - 6. Generally to carry out all transactions as they consider expedient in the interests of the Foundation and make all such arrangements and do such acts and things on behalf of the Foundation as may be usually necessary, desirable or expedient for the management of the affairs of the Foundation or in carrying out its objects.
 - 7. Any claim by a third party against the Foundation has to be restricted to the assets of the Foundation and shall not be extended to the personal properties of the Trustees unless it is established that the Trustees have not acted diligently or have misappropriated the funds of the Foundation.
 - To sign and verify vakalath, plaints, statements, execution petitions, affidavits, returns, appeals and other proceedings.
 - 9. If the objects for which this Foundation has been created shall fail and cannot be fulfilled, Managing Trustee shall be at liberty to transfer the property which is the subject of the Foundation to any other Institution / Trust having similar objects and also enjoying exemption U/S 80G of Income-Tax Act 1961.







BOARD MEETINGS:

- The Managing Trustee shall be the person responsible to call the meetings of the Board.
- 2. The Board may meet at periodical intervals as they think fit:
- The Managing Trustee if present, shall generally preside over the meeting of the Board.
- 4. The quorum for a meeting shall be two. In all matters not expressly otherwise provided for the decision of the majority of the Trustees present at the meeting of the Board shall be the decision of the Board. In the event of the votes being equally divided the Managing Trustee shall have a casting vote in addition to his vote as a member of the Board.
- 5. The business of the Board may be transacted either at the meeting of the Board or by resolutions passed in circulation. The circular resolution shall be deemed to have been passed if majority of the Trustees signify their consent in writing.

ACCOUNTS:

The accounts of the Foundation shall be closed every year on 31st March and Income and Expenditure Account and Balance Sheet as on that date shall be prepared.

The surplus fund if not set apart or applied for the Foundation objects within the year of account shall be accumlated for any specific object of the Foundation and invested in any manner authorised under the Income-Tax Act for the time being. The accounts of the Foundation shall be audited every year by a chartered Accountant.

GENERAL:

The Board shall have power to frame rules and regulations for the management and administration of the affairs and objects set by the Foundation Deed as they shall think fit and to alter or vary or cancel the same from time to time and to make new or additional rules and regulations.

The Power to amend will not include a Power to alter the Foundation's objects.

However, the Trustees shall proceed to amend the rules provided under this deed only after obtaining the prior permission of the commissioner of Income-Tax having jurisdiction over it. The activities of the Foundation shall be carried out within India only. The Foundation hereinabove constituted shall be irrevocable.

It is hereby declared that the income/funds of the Foundation will be solely utilised for the objects of the Foundation and no portion of it will be distributed among the trustees/members either directly or indirectly in the form of / profit, divident, interest, etc.

At present the Foundation does not own any other properties either movable or immovable other than this Corpus Fund of Rs.5006/-.
